2025 TERMS & CONDITIONS

PAYMENT TERMS: Seller accepts Check, Visa, MasterCard, Discover, American Express and Money Order. Dealer will be charged a \$25 service charge for any returned check. No discounts will be allowed unless taken according to Invoice or Program Terms.

SHIPPING:

- 10% S&H fee on all standard shipments
- \$250 minimum standard order; \$100 minimum reorder
- Seller will attempt to accommodate special shipping requests

CANCELLATIONS & CHANGES: Orders may be changed or cancelled up to 2 weeks prior to ship date.

RETURNS, CREDITS & EXCHANGES:

- Dealer has 15 days upon receipt to inspect product for broken, mishandled, or mis-shipped products
- Any requests accepted after 15 days are eligible for a 20% restocking fee.
- No shipments to Annalee will be accepted without a Return Merchandise Authorization (RMA) number on the box.
- If unauthorized non-current product is received as part of an authorized return, no credit will be issued.
- If product is being returned for a reason other than damage, the product and product boxing must be in "like new" condition or no credit will be issued on those items.

EXPRESSIONS & DESIGNS: Expressions on doll faces may differ from those pictured in catalogs and publications. There are up to eight different facial expressions for a single design. Minor design and accessory changes may be necessary.

APPOINTMENT OF DEALER: Seller hereby appoints Dealer as a non-exclusive, authorized retailer of all Annalee Dolls products, entitled to inform the public of such status by displays, advertisements and the like. Seller does not guarantee exclusivity in any region. Dealer must be in line with Seller's marketing efforts.

TRADEMARKS, COPYRIGHTS & ADVERTISING RESTRICTIONS: Annalee Dolls, and/or other Annalee Dolls products are owned and controlled by Annalee Dolls. All rights reserved. Our images, logos, likenesses, etc... may not be used or reproduced in any manner without written permission from Annalee Dolls.

DEFAULT: *Late payment will result in a loss of all discounts.* Seller will charge Dealer interest on all amounts 30 days past due at the rate of 1.5% per month (18% per annum), or the maximum amount allowed by law, whichever is less. Dealer will also be responsible for and shall reimburse Seller for any collection agency fees up to 25% of the balance owed.

DEALER'S CREDITS WORSENS: Seller has the right, in addition to other remedies provided by the law, to terminate any delivery or suspend further deliveries of other orders in the event Dealer fails to pay for any orders when the same becomes due. Should Dealer's financial condition become unsatisfactory to Seller, at Seller's sole discretion, Seller may require payments in advance or other security satisfactory to Seller prior to shipment of merchandise.
